Roll call

• The meeting was called to order at 9:02 a.m. by Vice-Chair Cody R. Rogers. New Mexico Law Enforcement Academy Staff Manager Jessica Arballo conducted roll call confirming the inperson attendance of members: Chief Erin Toadlena-Pablo, Chief Thomas Romero (ret.), Carly Huffman, Joseph Walsh, Vice-Chair Cody R. Rogers, and Dawn Myers. Sheriff Matthew T. Hutchinson, Chief Summer Mirabal, and Dr. Bobbie Green attended virtually. Member Julie Ball attended in person and arrived after the roll call at 9:12 a.m. A quorum was established.

Approval of agenda

• Member Sheriff Matthew Hutchinson moved to approve the agenda. Member Chief Summer Mirabal seconded. Vice-Chair Cody R. Rogers asked members for all in favor and those against. The motion passed with 9 votes in favor and none against.

Approval of minutes from March 20, 2025, Meeting

• Member Chief Erin Toadlena-Pablo moved to approve the minutes from March 20, 2025, special board meeting. Member Joseph Walsh seconded. Vice-Chair Cody R. Rogers asked members for all in favor and those against. The motion passed with 10 votes in favor and none against.

Law Enforcement Certification Board June 12, 2025, Meeting Minutes to provide public comments. The time afforded for each person wishing to speak was limited to (3) minutes. The audience members included Chief Christopher Williams, Martha Bird, Rachel Feldman, Valerie Morris, Cindy Paps, Mitsy Lettingham, Shiela Lewis, and Pam Rogers. Virtual participants include Senator Antoinio "Moe" Maestas and Chris Mechels.

Reports, Discussion and Action Items:

- I. Rule Making Working Groups
 - a. Misconduct Rules Working Group Member Member Julie Ball
 - Vice-Chair Cody Rogers stated there are two rulemaking groups that are active but have delayed due to other priorities. A contractor was hired to assist but has produced no deliverables, and the contract will expire in September. As a result, rule making efforts are essentially starting over, now with the support from the New Mexico Department of Justice. The Board is coordinating with New Mexico Law Enforcement Standards and Training Council to ensure consistency between overlapping rulemaking responsibilities. Despite limited staff, the Board is moving forward. Rulemaking remains a top priority.
 - b. Certification Qualifications and Issuance Rules Working Group Vice Chair Cody Rogers
 - Report discussed under above agenda item.
- II. Report from Vice Chair
 - Vice-Chair Cody Rogers stated the Board was informed that the contractor intended to support the rulemaking process was funded by the New Mexico Law Enforcement Standards and Training Councils budget, even though the scope included work for this board. No deliverables have been received under the contract. Staffing remains limited, and Deputy Cabinet Secretary/ Interim Director Sylvia Serna has agreed to assist in revising the organizational chart. The current structure appears heavy on administrative roles and light on investigators, a revised draft will be shared with board members for review. The CEO search is still ongoing, but immediate priorities include hiring investigators and essential staff to ensure continued progress on the caseload.
- III. Clarification of Legal Standards Applicable to Certification by Waiver Process
 - Vice-Chair Cody Rogers stated case law came out that the board was involved in and based on the case law, Vice-Chair asked board attorneys to clarify the process as it pertains to retirees. The order regarding the case law does not apply to 10.29.6.9 NMSA therefore the board cannot deny certification by waiver based on 10.29.6.9 NMSA. Member Julie Ball requested a copy of the court order. No action was taken.
- IV. Report from ad hoc working group regarding non-jurisdictional ("citizen") complaints
 - Vice-Chair Cody Rogers stated at the last meeting that an ad hoc working group was created to address the ongoing discussion around non-jurisdictional or citizen

complaint. After speaking with individuals on both sides of the issue, the controlling factor must be the statue as it currently stands- no future interpretations or desired changes. Vice-Chair Cody Rogers made a motion to request a formal legal opinion from the New Mexico Department of Justice. None opposed.

 - NMDOJ AAG Daniel Rubin presented a summary of the motions provided to the board. Respondent Patrick Rael answered questions from members. Member Joseph Walsh moved to adopt the proposed order provided by AAG Daniel Rubin. Member Chief Thomas Romero (ret.) seconded. None Opposed. 10 votes in favor. Motion carried unanimously.

Motion carried unanimously.
